Section 210.254 RSIMo requires notification that background checks have been conducted under the provisions of section 210.1080 RSIMo. Section 210.1080 RSIMo specifies criminal background checks for child care staff members. The requirements for religious organizations operating a child care facility are as follows: Facilities operated by a religious organization that receive federal funds for providing care for children must have qualifying background screening results for child care staff members as defined in 210.1080, 9 (RSIMo.) Facilities operated by a religious organization and that <u>do not</u> receive federal funds for providing care for children are <u>not</u> required to have qualifying background screening results for all child care staff members of facilities operated by a religious organization that receive federal funds for providing care for children, with disqualifying background screening results are prohibited from being on the premises during child care hours. Facilities operated by a religious organization that receive federal funds for providing care for children, with disqualifying background screening results are prohibited from being on the premises during child care hours.
